INSTRUCTIONS

- 1 Replace swing arm pivot shaft as per Harley Davidson Service Manuel (See Section 2; Page 2.89) for removal and installation instructions.
- 2 Install foot peg clevis, bolt and cover onto the end of the shaft. As shown in Fig 1 & 2. Use Locktite!!

NOTE: There is a right and a left cover.

- 3 Torque to 35 lbs
- 4 For `05 & Up V-Rods only require istallation of three piece bushing set. Bushings are to be installed on existing shaft as shown in Fig 3.
